Artist Agreement

All artwork must be reviewed and approved by Palace Management before hanging on our walls. Palace reserves the right to remove any artwork deemed inappropriate or not conducive to the business (for example nudes, political or religious statements, violence, etc.).

Palace will post your biography and website information on our website <https://www.palaceartsupply.com/featured-artists> for the month that your work is hanging in our store. We ask that you send out an invite to your mailing list and promote your showing with Palace Art & Office Supply of Capitola.

Gallery Space

The space provided is located on the front wall of our Capitola store, behind the cash registers, with maximum visibility to our customers. This space is 20' wide by 4' tall approximately and is elevated above a work counter. This space will accommodate five to ten framed and flat pieces that are (not smaller than) 11x14 to (not larger than) 22x28 finished.

All artwork must be framed and provide a cohesive look.

The exhibit must include an artist's biography (single sheet) and a title card for each piece. Title cards need to be printed clearly on a business card size (2"x3.5") card-stock and include the name of the piece, medium, substrate, artist's name and price or "not for sale".

Artists must be present to hang all artwork. All work is hung on the first Tuesday of the month, by appointment only.

The exhibit ends on the last Saturday of the month and you will be required to remove your art work from the premises on that day. Palace is not responsible for removing or storing your work, so plan accordingly.

Works of art are for exhibit only. If a customer is interested in purchasing a piece, we will have them contact the artist directly. Any sale of artwork must be conducted outside of Palace. If a piece is sold, it should remain on the wall until the end of the show unless an approved replacement piece is available.

Palace will not be held liable for loss or damage to artwork. By virtue of the secure location within the store, artwork is relatively safe, however all art displayed at Palace is at the artist's own risk.
